### **Definitions:**

Profile – prescribed course sequence for completion of a specific major, based on the student's year of entry into that major.

## **Policy:**

- I. The successful completion of a graduate program of study, identified as a post-master's certificate program in the official College Catalog, leads to a post master's certificate. To be eligible for a post-master's certificate from the College, students are expected to satisfy the following:
  - A. Complete course requirements in their specific program, as set forth in the official College Catalog. Only courses numbered 500 and above can be applied toward meeting graduation requirements for a post-master's certificate.
  - B. Complete a minimum of 15 graduate-level credits at Penn College.
  - C. Complete all course requirements and earn at least a 2.00 graduation grade point average and at least a 2.00 cumulative grade point average in all major courses.
- II. The successful completion of a graduate program of study, identified as a master's degree program in the official College Catalog, leads to a master of science degree. To be eligible for a master of science degree from the College, students are expected to satisfy the following:
  - A. Complete course requirements in their specific program, as set forth in the official College Catalog. Only courses numbered 500 and above can be

applied toward meeting graduation requirements for a master of science degree.

- B. Complete a minimum of 30 graduate-level credits at Penn College.
- C. Complete all course requirements and earn at least a 2.00 graduation grade point average and at least a 2.00 cumulative grade point average in all major courses.
- III. The successful completion of a five-year program of study, identified as a combined bachelor/master's degree program in the official College Catalog, leads to a combined bachelor/master's of science degree. To be eligible for a combined bachelor/master's of science degree from the College, students are expected to satisfy the following:
  - A. Complete course requirements in their specific major, as set forth in the official College Catalog. Only courses numbered 500 and above can be applied toward meeting graduation requirements for a master of science degree.
  - B. Complete a minimum of 30 graduate-level credits at Penn College.
  - C. Complete all course requirements and earn at least a 2.00 graduation grade point average and at least a 2.00 cumulative grade point average in all major courses.
- IV. The successful completion of a four-year program of study, identified as a bachelor degree program in the official College Catalog, leads to a bachelor of science degree. To be eligible for a bachelor of science degree from the College, students are expected to satisfy the following:
  - A. Complete course requirements in their specific majors, as set forth in the official College Catalog. Students may substitute courses with prior written permission of the appropriate School administrator. Only courses numbered 100 and above can be applied toward meeting graduation requirements for a bachelor of science degree.
  - B. Complete a minimum of 36 credits at Penn College for coursework prescribed in the final four semesters (spring and fall) of a student's profile. The calculation will include credits for any summer coursework required within or after the final four semesters. Credit earned by credit by examination, work/life experience, or other applicable advanced credit may be included in the credit minimum if satisfying courses prescribed in the final four semesters of the student's profile.
  - C. Complete a minimum of 24 credits at the 300/400 level.

- D. Complete all course requirements and earn at least a 2.00 graduation grade point average and at least a 2.00 cumulative grade point average in all major courses.
- E. Students may enroll in a second bachelor's degree if that curriculum includes *at least* 30 credits of non-duplicated courses that are not part of the first degree. See Dual Degree Policy, <u>P 4.20</u> for details.
- F. Students may earn up to two academic minors, providing the following requirements are met:
  - i. The student must have completed 12 of the credits required for the minor at Penn College.
  - ii. The student must have completed the required number of credits at the 200 level or higher as set forth in the official College Catalog.
  - iii. The minor(s) cannot be within the same discipline as the declared major (including a dual degree).
  - iv. The minor can be declared no later than the petitioning period in the student's final semester.
  - v. All coursework applied to the minor must be completed with a grade of 'C' (2.0) or higher; pass/fail courses cannot be applied toward a minor.
  - vi. Baccalaureate-degree graduates may re-enroll up to two years after graduation to complete a minor. The completed minor will be indicated on the official transcription; a new diploma will not be issued.
- G. Fulfill all financial obligations to the College. Diplomas will not be issued to students with holds on their records.
- V. The successful completion of a five-year program of study, identified as a bachelor degree program in the official College Catalog, leads to a bachelor of architecture degree. To be eligible for a bachelor of architecture degree from the College, students are expected to satisfy the following:
  - A. Complete course requirements in their specific majors, as set forth in the official College Catalog. Students may substitute courses with prior written permission of the appropriate School administrator. Only courses numbered 100 and above can be applied toward meeting graduation requirements for a bachelor of architecture degree.
  - B. Complete a minimum of 36 credits at Penn College for coursework prescribed in the final four semesters (spring and fall) of a student's profile. The calculation will include credits for any summer coursework required within or after the final four semesters. Credit earned by credit by

examination, work/life experience, or other applicable advanced credit may be included in the credit minimum if satisfying courses prescribed in the final four semesters of the student's profile.

- C. Complete a minimum of 48 credits at the 300/400 level.
- D. Complete all course requirements and earn at least a 2.00 graduation grade point average and at least a 2.00 cumulative grade point average in all major courses.
- E. Students may enroll in a second bachelor's degree if that curriculum includes *at least* 30 credits of non-duplicated courses that are not part of the first degree. See Dual Degree Policy, <u>P 4.20</u> for details.
- F. Students may earn up to two academic minors, providing the following requirements are met:
  - i. The student must have completed 12 of the credits required for the minor at Penn College.
  - ii. The student must have completed the required number of credits at the 200 level or higher as set forth in the official College Catalog.
  - iii. The minor(s) cannot be within the same discipline as the declared major (including a dual degree).
  - iv. The minor can be declared no later than the petitioning period in the student's final semester.
  - v. All coursework applied to the minor must be completed with a grade of 'C' (2.0) or higher; pass/fail courses cannot be applied toward a minor.
  - vi. Baccalaureate-degree graduates may re-enroll up to two years after graduation to complete a minor. The completed minor will be indicated on the official transcription; a new diploma will not be issued.
- G. Fulfill all financial obligations to the College. Diplomas will not be issued to students with holds on their records.
- VI. The successful completion of a two-year program of study, identified as an associate degree program in the official College Catalog, leads to an associate of applied science, associate of arts, or associate of applied arts degree. To be eligible for an associate's degree from the College, students are expected to satisfy the following:
  - A. Complete courses required in a specific major as set forth in the official College Catalog. Students may substitute courses with prior written permission of the appropriate School administrator. Only courses

numbered 100 and above can be applied toward meeting graduation requirements for an associate's degree.

- B. Complete a minimum of 30 credits in courses offered at Penn College. Credit earned by credit by examination, work/life experience, or other applicable advanced credit may be included in the 30-credit minimum. At least 18 of the credits completed at Penn College must be for coursework prescribed in the final two semesters (spring and fall) of a student's profile. The calculation will include credits for any summer coursework required between or after the final two semesters.
- C. Earn at least a 'C' average (2.00 graduation grade point average) and complete all required courses with a grade of 'D' or better. Certain majors require completion of all required courses with a grade of 'C' or better. These majors are identified in the official College Catalog.
- D. Students may enroll in a second associate's degree if that curriculum includes *at least* 15 credits of non-duplicated courses that are not part of the first degree. See Dual Degree Policy, <u>P 4.20</u> for details.
- E. Fulfill all financial obligations to the College. Diplomas will not be issued to students with holds on their records.
- VII. Certificates will be awarded for the successful completion of a program of study identified as a certificate program in the official College Catalog. To be eligible for a certificate from the College, students are expected to satisfy the following:
  - A. Complete courses specified for a given program of study as set forth in the official College Catalog. Students may substitute courses with prior written permission of the appropriate School administrator. Courses numbered 010 and above can be applied toward meeting graduation requirements for a certificate.
  - B. Complete at least half of the required credits, including the last semester as prescribed on the student's profile, at Penn College. This includes credit received for credit by examination, work/life experience, or other applicable advanced credit.
  - C. Earn at least a 'C' average (2.00 graduation grade point average) in all courses and complete all required courses with a grade of 'D' or better. Certain majors require completion of all required courses with a grade of 'C' or better. These majors are identified in the official College Catalog.
  - D. Fulfill all financial obligations to the College. Diplomas will not be issued to students with holds on their records.

- VIII. Immersions may be earned by students seeking associate's, bachelor's, and combined bachelor/master's degrees. Students may earn up to two immersions, providing the following requirements are met:
  - A. The student must have completed all of the required credits for the immersion at Penn College.
  - B. The student must have completed at least three credits at the 200 level or higher as set forth in the official College Catalog and a one-credit summative project.
  - C. The immersion can be declared no later than the petitioning period in the student's final semester.
  - D. All coursework applied to the immersion must be completed with a grade of 'C' (2.0) or higher.
- IX. If after completing the final semester of a certificate, associate's, or bachelor's degree, the student has not completed all of the coursework required by their major, the student may take the remaining courses from another accredited college/institution, providing that all other requirements are met, including the minimum Penn College credits stipulated in previous sections of this policy. It is the student's responsibility to verify that the course(s) will satisfy the requirements of the desired Penn College major. Unless otherwise specified in the respective program curricula, graduate students do not have the option of completing final coursework elsewhere.
- X. To be eligible to graduate from Penn College, a student must "petition to graduate" through the Registrar's Office. This can be done in person or by phone. There is no graduation fee required when students petition to graduate.
- XI. The Vice President for Academic Affairs and Provost, or designee, must approve all exceptions to the graduation requirements.
